**Archery Equipment
Hire Agreement**

Rules of hire:

Definitions

1. The “Club” is the Malvern Archers Archery Club affiliated to Archery GB based at Manor Park Sports Club Albert Road Malvern WR14 2TL.
2. The “Range” is any archery range registered by The Club with Archery GB, and its associated storage buildings.
3. An “Authorised Member” is any current (a) member of The Club committee, or (b) Club coach.

The hire of the Equipment:

- Shall be of a minimum duration of 4 weeks and a maximum of 12 weeks.
- The rent for the hire will be £4 per week, paid in advance, invoiced every 4 weeks by email.
- All the equipment hired under this agreement remains the property of the Owner.
- Collection of the Equipment will be from an Authorised Member at the Manor Park location.
- Return of the equipment will be to an Authorised Member, at the Manor Park location.
- The Owner reserves the right to request return of the Equipment at any time. The request can be in person, by letter, text or by email from a member of the Club Committee. The Owner does not need to provide reason for the request.
- Failure to return the Equipment within 7 days of such a request will incur a further charge of £1 per day until it is returned. The Committee have the discretion to waive this charge if they see fit.
- The Hirer shall undertake to keep the equipment in a safe place in such a way as to prevent death, injury or damage or theft.
- The Equipment can only be used and hired whilst the Hirer is a Full Member of the Club.
- The Equipment can only be used for the reason it is ordinarily intended, and at an Archery GB registered range.
- To the extent that the law allows the Hirer shall indemnify the Owner and its Committee members in relation to any death, injury loss and damage caused when the equipment is not used in accordance with the regulations of the Club and this Agreement.
- Any damage to the equipment however caused must be reported to the Club Equipment Officer as soon as possible. equipment@malvernarchers.co.uk
- The Hirer will be responsible for any damage caused to any of the equipment through misuse or negligence whilst it is under their control. The Committee, or nominated Committee member, shall determine the cost of repairs or replacement which the Hirer will be required to pay. If there is any dispute over these costs it will be examined by the Club Chairman and their decision will be final. These costs will be invoiced to the Hirer by email.
- Any damage caused to the equipment through reasonable use, wear and tear will not be refundable by the Hirer.
- If any or all of the equipment is lost or stolen the Hirer will be responsible to refund the Owner the full cost of replacing all the missing equipment within 21 days. Any equipment subsequently recovered will be the property of the Hirer.
