## Indoor briefing sheet

This is a reminder sheet for the tasks to be undertaken by **The Field Captain** prior to commencing a session indoors at The Dome.

### Prior tasks:

1. Check that the far toilets are vacant.
2. Check that the entry warning sign is in place.
3. Check that the middle doors are closed.
4. Check coils in electrical cables are, as far as is practicable, outside of the live shooting area.

### Briefing to archers:

1. Reminder that the far toilets are out-of-bounds during the session
2. Reminder that nobody is to enter or leave the venue whilst shooting is under way, and that such activity should be reported to The Field Captain
3. Reminder of the hazard posed by the lights (cable trip & casing heat).
4. Outline of the coming session (practice / CTD / etc.)
5. Introduce any new members / visitors and assign buddy if indicated.
6. Remind archers to 'warm up'.
